## ORDER

Government vide GO read (1) above have issued orders revising the pay and allowances of the University Employees. Accordingly pay of University Employees has been fixed in the revised scales of pay as per the rules for fixation of pay. Now Government vide GO read (2) above have modified the scale of pay of the posts of Assistant Registrar, Assistant Registrar (HG), Deputy Registrar and Joint Registrar with effect from 01-07-2009 as detailed below:

Sanction has been accorded by the Vice-Chancellor to the following:

1. The Assistant Registrars, Assistant Registrars (HG), Deputy Registrars and Joint Registrars are permitted to exercise revised option in response to the current Pay Revision provided, the modification of scale of pay takes effect on a date prior to the date of option exercised by them for the current Pay Revision subject to all other conditions prescribed for the exercise of option as per the GO read (1) above. Such employees are also permitted to exercise revised option for fixation of

pay under Rule 28A Part I KSR on their subsequent regular and ratio based promotions. The revised option is to be filed within 3 months from the date of this order.

- 2. In the case of employees retired from service prior to 01-07-2009, their pension shall be revised by the pension sanctioning authorities in eligible cases.
- 3. In all other cases, pay fixation shall be done by Finance Branch on the basis of the revised option tendered by the employees concerned.

Orders are issued accordingly.
